Superintendent Report: Mr. DiRosa announced the six person hiring team interviewed a candidate for the Middle School Principal position. Mr. DiRosa stated the original candidate withdrew from accepting the position due to housing issues. Mr. DiRosa stated the budget is at \$450 per student, which is up \$100. We have based our budget on 800 students and are hopeful for more. Mr. DiRosa gave an update on the \$1.6 million Esser III funds from the Federal Government. Mr. DiRosa indicated the money will be used for prevention and mitigation, in-person learning, outside custodial services, 2 daily substitutes in each building, counseling and behavioral interventions, literacy/coaching, technology, bus sanitation and PPE equipment. Mr. DiRosa stated a survey was sent to stakeholders asking their input on how the funds should be used. The responses were considered in the final plan. The use of funds is

open for public input. Amy Derrer asked if Kelly Godfrey would be starting in the fall. Mr. DiRosa stated yes. Mr. DiRosa announced we have an Elementary teaching position open. At the high school, we are searching for a Science teacher and an English teacher. Gerald Clark asked if all classrooms lock from the inside and if the rooms were equipped with the boot. Mr. DiRosa stated they do lock however; we do not have the boot. Mr. DiRosa stated we requested door security in the State Police Grant, which we did not receive. Mr. DiRosa indicated there are some additional security dollars in the 22/23 State budget. Dale Ackler asked if there had been any updates on gun safety legislation. Mr. DiRosa stated he has not seen any guidance yet.

Approve DMBurr Custodial Contracts

Mr. DiRosa stated this is a 3-year contract. Custodians will receive a raise the first 2 years and will negotiate for the 3rd year. Mr. Thompson asked their current wage. Mr. Dirosa responded \$13.00 an hour.

Adopt the Authorizing Resolution for the November election

Mr. DiRosa stated the November election is for 1 mill restoration of the Headlee. The Headlee is rolled back for the 2022 levy so we levy less that the 18 mills. Mr. DiRosa stated that we are asking for a 1 mill cushion for 4 years which allows us to levy the full 18 mills. Mr. DiRosa indicated you could never ask for more than 18 mills.

Items for Future Consideration: Dale Ackler asked when the next board meeting will be held. Burt Thompson sated August 9th. Mr. DiRosa stated he is hoping to have a middle school principal on the August agenda for approval. Mr. DiRosa stated the next bond meeting will be held at the Mancelona Township hall on July 25th at 4:00. Mr. DiRosa asked that the committee join at the bowling alley on August 2nd, election day. Mr. DiRosa stated we may not know the election results until the next morning.
